The town board meeting was held on June 10, 2025 at the town justice building.

Councilman Grescheck led us in the pledge of allegiance.

Supervisor Bronner called the meeting to order at 7:00 pm.

The town clerk read minutes from May 13, 2025 town board meeting. Supervisor Bronner asked if any corrections, additions, or changes to the minutes as read. Councilman Voght made motion to accept and Councilman Gerhardt second. All approved.

Supervisor Bronner advised on this night was the public hearing for Local Law #2-2025 and wanted residents to know the reason for the law. The main reason is zoning in the town of Stark. At this time, town of Stark has no zoning board of appeals. By the state law, the town must have this requirement because the town board must be separate from the zoning board of appeals. The planning board can be affiliated with the zoning and the town board can act as a planning board, but must remain separate from the zoning board, which is the main reason the town board is combing the planning and zoning board.

Open portion of the public hearing was at 7:10 pm. There was a continuation of debate by the residents as to why not a five member planning, zoning board. After much discussion, the vote from the town board was suspended to the next public hearing to be held on July 8, 2025 and the vote would happen then on Local Law #2-2025. Open portion of the meeting was closed at 7:40 pm.

A motion to adopt a resolution for Local Law #3-2025 for the junkyard was made by Councilman Gerhardt and seconded by Councilman Hubiak. There was a roll call vote. All approved. A motion was needed to schedule a public hearing July 8, 2025 for Local Law #3-2025. Councilman Grescheck made motion and Councilman Voght seconded. All approved.

Supervisor Bronner advised that Councilman Gerhardt, Superintendant Hazczewski, and himself met with the owner of the property for the salt, sand barn and after five drafts, obtained the correct procedure and will be close to three acres to purchase. Supervisor Bronner will email to the members of the town board.

Supervisor Bronner passed the monthly expenditures for the town board to review for the final state snow, the cable tv in town from Charter Communications, and inspection report from the dog control officer.

Supervisor Bronner advised this is the month for advertising for fuel bids which will be opened at the next meeting or can be delayed until August as prices are lowering.

Supervisor Bronner received a letter from Codes Officer Phil Greene as he is retiring from employment with the town of Stark effective June 27, 2025 to be eligible to collect his retirement benefits and wished to be reappointed after July 2, 2025 as codes officer for the town of Stark. A motion needed to accept letter of resignation. Councilman Gerhardt made motion and Councilman Grescheck seconded. All approved.

The town board reviewed the Supervisor's report. Councilman Grescheck made motion to approve and Councilman Hubiak seconded. All Approved.

The town clerk's report was reviewed by the town board consisting of a duplicate marriage certificate, 4 dog licenses, and a building permit totaling \$84.00. Councilman Voght made motion to approve and Councilman Hubiak seconded. All approved.

The town board reviewed the General and Highway Fund vouchers to pay bills. Councilman Grescheck made motion to pay the bills and Councilman Hubiak seconded. All approved.

The next town board meeting will be held on July 8, 2025 at 7:00 pm and there will be a public hearing at that time for Local Law #2-2025 and Local Law #3-2025.

Councilman Gerhardt made motion to adjourn and Councilman Hubiak seconded. All approved. Meeting was adjourned at 8:12 pm.
